Group 2 – Young Gardeners

Age Group 1 (Ages 6 to 11 years) – Best display of growing flowers in containers or garden.

Age Group 2 (Ages 12 to 16 years) – Best display of growing flowers in containers or garden.

Group 3 – Businesses and Organisations

Best display of growing flowers in containers or window display.

Category 4 – Illogan School

To be organised by the school

On a vote being taken the matter was approved unanimously.
