- **b. Regeneration Illogan Parish Regeneration Group** Cllr Ekinsmyth reported the members of the IPRG had been active with the Parish Plan.

Tolvaddon Regeneration Group – Cllr Ekinsmyth reported that he had attended a meeting with Amanda Leonard (Regeneration Officer) & discussed arrangements for the development of the new play park on Rosemullion Gardens, and also introduced the concept of the 'Green Ripple' project (see earlier reports to Council). Together these projects represent a considerable investment in the Tolvaddon community and the 'Green Ripple' in particular will eventually benefit the rest of the Parish and wider afield.

c. Representatives to Outside Representatives

Friends of Maningham Wood – Cllr Mrs Cadby reported on the Dawn Chorus event that had recently took place, the coppicing of some holly trees, dog notices, the weeding of the Platt carried out by the Parish Contractor, removal of Spanish Bluebells and Mombretia from the wood and managing the wildlife.

ILLOGAN PARISH COUNCIL

Cornwall Association of Parish Councils – A report from Cllr Ekinsmyth. He had attended the AGM and Conference and one other meeting. The main business was to confirm constitutional arrangements so as to conform with new Cornwall Council arrangements. The current Executive Committee members to remaining post plus 6 further representatives elected to fill vacancies. Four members will represent the new Cornwall Council service delivery areas. All meetings attended were informative and of direct relevance to Illogan. The training we received was attended by most councillors who took the opportunity to update knowledge on Standing Orders.

Community Network Area - Cllr Ekinsmyth had attended 3 meetings. At the first it was decided to split the group into two areas whose interests were more in common; the CPIR (Camborne, Pool Illogan and Redruth plus Portreath), and the Mining and other villages outside the main conurbation. At subsequent meetings we agreed Key Strategic Objectives to be pursued by the network and in the first instance taken to the County overarching sustainable planning group. All Illogan Parish objectives were taken from the Parish Plan survey.

Red River Working Party - there had been no meetings during the year.

Tehidy Country Park Partnership Advisory Group - no meetings during the year.

Mineral Tramways – Cllr Mayne reported that the Cornwall Council Mineral Tramways Committee planned to meet later on in the year.
