The Chairman welcomed all present. Apologies for absence were received from Cllrs Mrs V. Poole.

The Police Report was brought forward to allow the officers to attend an incident.

It was proposed by Cllr Mayne, seconded by Cllr Dunstan. Vote in favour 11, Against 1, Abstain 1.

Resolved not to support the recommendation made by The Friends of Maningham Wood.

The Clerk explained the quotes that had been sought to print the next issue of the Illogan Review. Some lengthy discussion ensued.

Cllr Ekinsmyth proposed, and was seconded by Cllr Cadby.
