TO RECEIVE CORRESPONDENCE REGARDING THE DEVOLUTION OF ILLOGAN PARK, AGREE ANY FUTURE ACTIONS AND ANY ASSOCIATED EXPENDITURE

All correspondence was circulated to members.

Members expressed their despair with Cornwall Council's response to the letter sent after the last meeting of this committee; they wondered whether Cornwall Council had actually read the information provided for example the comment regarding the contributions from the Football Club and Rugby Club.

Cllr Wilkins reported that he had had a long conversation with Mrs Theobold, Cornwall Council Finance Director. She advised

Cllr Wilkins that Cornwall Council were minded to grant £25,000.00 to Illogan Parish Council from the devolution pot; this had been approved by the portfolio holder, Cllr Rowe. Mrs Theobold had also confirmed that the freehold of Illogan Park had been approved to be transferred to Illogan Parish Council. She had requested that Illogan Parish Council amended their business plan to reflect the reduction in the grant to £25,000.00 and that the amended business plan is submitted on Tuesday 18^{th} March 2014. Once the amended business plan was received by Cornwall Council the Cornwall Councillor would have to sign a document to confirm that they support the transfer of Illogan Park to Illogan Parish Council.

Members raised concerns that Cornwall Council were not prepared to put in the writing the grant figure of £25,000.00 that they had verbally stated that they were minded to support.

It was felt that the business plan submitted by Illogan Parish Council was sufficient without giving away the Council's negotiating position.

The S106 funds would be applied for as soon as an application form was sent to Illogan Parish Council.

Members felt that it was unacceptable that Cornwall Council had not provided the reports requested and had once again ignored the query regarding TUPE. Cornwall Council must hold an asbestos register, if they did not they would be breaking criminal law. Illogan Parish Council needed to ensure that they had a copy of the asset register to ensure that they would not be aiding and abetting Cornwall Council and to ensure that Illogan Parish Council did not leave itself liable. Cllr Wilkins said that he would email Cornwall Council and ensure that the reports were sent to Illogan Parish Council. It was noted that the solicitor should request copies of certain reports i.e. asbestos, mining etc. Members discussed the potential additional cost implications of demolition if there was asbestos present depending on the type and quantity. A member who had experience of working in buildings owned by Cornwall Council said that they only had the basic asbestos surveys completed which only covered asbestos that could be seen and did not look into voids etc; they suggested that Illogan Parish Council could get a more detailed asbestos and demolition survey completed. Members asked the Clerk to obtain a quote for an asbestos survey.

It was confirmed by members that there would be no attempt to proceed or sign anything without all of the relevant requested

information and reports – the asbestos register, electrical reports and answer to the question of whether TUPE applies.

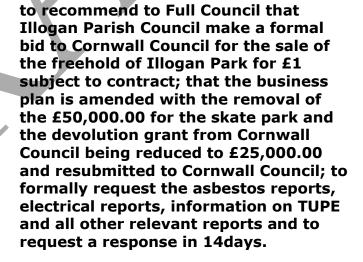
Members confirmed that all correspondence and negotiations should be made through the Clerk to Council.

Members queried whether the freehold of Illogan Park would be sold to Illogan Parish Council under contract or whether the freehold would be transferred to the Council. It was suggested that a caveat regarding consequential costs should be considered.

Cllr Mrs Ferrett proposed that the business plan was re-submitted with the removal of the £50,000.00 for the skate park and the devolution grant from Cornwall Council being reduced to £25,000.00; that we write to Cornwall Council explaining that the Council would apply for the S106 monies as soon as an application form had been submitted; that it is reiterated that Illogan Parish Council are still awaiting all of the requested reports and information and that a response is requested within 14 days. There was no seconder.
