## PM14/12/10 TO RECEIVE A REPORT AND RECOMMENDATIONS FROM THE FOOTPATHS WORKING PARTY AND AGREE ANY FUTURE ACTIONS

It was proposed by Cllr Mrs Ferrett, seconded by Cllr Mrs Roberts and

#### PM14/12/10.2 RESOLVED

to receive and approve all of the recommendations from the Footpaths Working Party as follows:

- that for the paths that are cut twice that in 2015 the first cuts are completed between mid-April and the end of May; the Clerk and 2 Councillors would liaise as to when the paths should be cut and the Clerk would then instruct the contractor. The cutting time would be reviewed for 2016.
- that for the paths that are cut twice that the second cuts are completed between mid-August and the end of September; the Clerk and 2 Councillors would liaise as to when the paths should be cut and the Clerk would then instruct the contractor. The cutting time would be reviewed for 2016.
- that the one cuts paths are cut in June; the Clerk and 2 Councillors would liaise as to when the paths should be cut and the Clerk would then instruct the contractor. The cutting time would be reviewed for 2016.
- that a letter is sent to the Council's contractor stating that he is required to notify the Clerk of any low hanging branches and any other obstructions he observes on the footpaths; that due to Cornwall Council's budget cuts it has been necessary for this Council to review their contracts resulting in the amended cutting regime and highlighting the standard that the Council expect the work to be completed to and appropriate communication and liaison with the Clerk; payment of invoices would only be made on adherence to the contract and completion of the work to a satisfactory standard; a response and acceptance deadline would be included in the letter; the Clerk would draft the letter and it would be considered at the next **Planning and Environmental Services** Committee meeting.
- that a rota of Councillors who are able to check footpaths is compiled from the Full Council to spread the workload amongst all councillors; each councillor should be given a map of the footpaths and councillors

## should check the footpaths promptly on notification that they have been cut.

On a vote being taken the matter was approved unanimously.

Cllr Mrs Ferrett reported that she had received an email in response to the article in the winter edition of the Illogan Review regarding footpaths. She would report the contents of the letter to the next meeting of the Footpaths Working Party.

## PM14/12/11 TO RECEIVE AN UPDATE FROM CLLR EKINSMYTH ON ROADS (PM14/09/16.2 - 03.09.14)

Cllr Ekinsmyth reported that he was talking to Cormac regarding a number of issues with the roads. He would be going around the parish with a Cormac officer to look at the roads. Cormac were completing work on the roads and he had asked that they kept him informed of what they were doing and when.

There was a list of seven volunteers for the roads safety scheme. The police were currently completing checks on the volunteers. It was hoped that the training would take place in the New Year; when the volunteers had monitored the safety of the roads a strategy could be compiled to try and resolved the issues highlighted.
