Mr Stuart Denslow, Pine Tops, Halgoss Road, Tehidy, Camborne Full planning permission for the construction of a dwelling, access and garage

Mr Denslow explained the history of the site. He stated that the tree officer and highways officers were now happy with the revised access. The plot is barely visible to neighbouring properties. The plot was 1.3 acres and the dwelling would fit well on the plot. The design of the dwelling was not dissimilar to three new houses built on Mount Whistle Road. The ridge height of the dwelling had been kept low creating an alpine chalet style house. The dwelling was orientated to avoid privacy issues and there were no windows on the north east side on the 1st floor level to avoid overlooking. A full tree survey had been completed and no protected trees were being removed. A list of the trees to be removed was given to members and the context of the number of trees to be removed and the number of trees on the site was explained. The applicants were prepared to work with the tree officer with regards to replanting. He felt that the house was best placed on the plot, used high quality finishes and it would fit well within the local area.

The access to the site, retaining trees between neighbouring properties, planting of a native hedge was discussed.

It was proposed by Cllr Ford, seconded by Cllr Ekinsmyth and

that Illogan Parish Council offers no objections to the planning application for Pine Tops on the basis that there are no material planning objections that come forth from the highways officer or tree officer.
