Members discussed whether the planning application had been approved; the Clerk reported that the application had been withdrawn. Members consider what

actions could be taken i.e. replanting of the trees etc; it was noted that there had not been any planning notices displayed at the site and that the trees were felled shortly after the last meeting of this Committee. Further to discussion:

The Clerk would also request clarity regarding Tree Preservation Orders (TPO's).

The litter pick days could be publicised in the Illogan Review. Cllr Pavey said that he would speak to Cllr White about how he had organised and started the litter picking days in Camborne and he would report back to the next meeting of this Committee.

Cllr Ekinsmyth did not believe that the situation county wide had changed since Illogan Parish Council last discussed flytipping in February 2015. The survey regarding charges to dispose of waste at the dips and flytipping had not been completed.

It was noted that an article had been written for the Illogan Review and would be include in the autumn edition.

Cllr Mrs Roberts felt that there were insufficient litter bins in the area especially considering there were 2 fish and chip shops.
