The Clerk reported that during the annual PAT Testing concerns were raised concerning the condition of the Christmas Lights. A qualified electrician had inspected the lights and had condemned their suitability for use. The main issues with them were the connections from power source to Festoon cable were connected using non insulated (chocolate box type) connectors. These were totally unsuitable for outside use. Several of the light sockets were suffering from corrosion internally particularly where missing bulbs had not been replaced. Lastly, individual bulb hangers were showing signs of corrosion throughout the lengths. The Clerk had destroyed and disposed of both sets of lights.
