# CL17/02/9 TO REVIEW THE 2016 ILLOGAN CHRISTMAS LIGHTS SWITCH ON EVENT AND AGREE ANY FUTURE ACTIONS

It was felt overall, the event went well and there was good attendance.

There were concerns that the Council's poster had been defaced when it had been displayed in the Robartes Arms; the bottom half that advertised the Park Bottom event had been torn off.

The Robartes Arms were making out that the Christmas Lights Switch On was their event when it was the Council's.

The Robartes Arms had not told us that they would be putting the BBQ out the front and it was in the wrong place.

Members consider whether there were any other suitable locations in Illogan to place the Christmas tree. They considered the road closures, power supply, visibility of the tree etc. It was agreed that the tree would remain outside the Robartes Arms and that in 2017 the posters would be sent to the pubs with a letter requesting that they keep the posters intact. All correspondence and advertising including the carol sheets would have Illogan Parish Council and the logo on them.

It was noted that the Co-Op gave away mince pies on the evening.

Western Power had let the Council down at the last minute with the distribution of the road signs. It was agreed that the Council would consider how the road signs would be distributed next year.

There were not enough lights on the trees on The Platt and it was agreed that more lights would be put up in 2017.

The Illogan Christmas Lights Switch On Event 2017 would be held on Friday 8<sup>th</sup> December.

## CL17/02/10 TO REVIEW THE PARK BOTTOM CHRISTMAS LIGHTS SWITCH ON EVENT AND AGREE ANY FUTURE ACTIONS

The event went well although there seemed to be more people staying inside the New Inn this year than in previous years. This could have been because it had been raining although it was dry for the duration of the event it may have put people off going to stand outside. The music before and after worked well. It was agreed that the Clerk and a Councillor would be sufficient to man the road closure.

It was agreed that to consider the erection of a gazebo in the New Inn car park in 2017 to prevent having to close the road.

The Park Bottom Christmas Lights Switch On Event 2017 would be held on Saturday 9<sup>th</sup> December.

# CL17/02/11 TO CONSIDER ERECTING A CHRISTMAS TREE AT A SUITABLE LOCATION IN TOLVADDON IN 2017, CONSIDER SUITABLE LOCATIONS AND AGREE ANY FUTURE ACTIONS

Members felt that they would like to erect a tree in Tolvaddon.

They consider suitable sites such as to the front of Tolvaddon Community Fire Station, to the rear of the Council Office and near Adelaide Stores. It was also suggested that 2 smaller trees (9ft) were erected by Adelaide Stores and Tolvaddon Community Fire Station. The trees could be decorated with baubles and battery operated lights.

It was agreed that an article would be put in the Illogan Review stating that Illogan Parish Council would really like to erect a Christmas tree in Tolvaddon. The tree must be clearly visible and preferably have access to an electrical supply. Does anyone have any suggestions as to where a tree could be located in the Tolvaddon area.

## CL17/02/12 TO CONSIDER WHETHER TO HOLD A COMMUNITY EVENT DURING 2017 AND AGREE ANY FUTURE ACTIONS

The Clerk reported that following a post the Council put on Facebook, one resident suggested that an 'it's a knockout' type event was held. Members felt that such an event would take a lot of organising; that there would be a lot of health and safety issues to consider and overcome and that it could be costly.

Members considered a fun day with a 'tug of war' between the football and rugby clubs or the pubs, walking football, a fancy dress parade, bouncy castles, children's rides, stalls etc. Members however, did not want to clash with Illogan Parish Fair. It was suggested that if such an event was held that it should take place before the children break up for the summer holidays.

It was agreed that this item would be considered further at the next meeting.
