ILLOGAN PARISH COUNCIL

Minutes of the Extra Ordinary Full Council Meeting held at the Penwartha Hall on Wednesday 31st January 2018 at 7.00pm.

The Chairman explained the safety procedures.

FC18/01/25 CHAIRMAN'S WELCOME AND APOLOGIES FOR ABSENCE

Apologies were received from Cllrs Ms Cadby, Holmes, Miss Pollock and Szoka. Cllr Ekinsmyth apologised for late arrival.

There were no members absent.

FC18/01/26 MEMBERS TO DECLARE DISCLOSABLE PECUNIARY INTERESTS AND

There were no interests declared.

There were no applications from members for dispensations.

FC18/01/28 PUBLIC PARTICIPATION ON ITEMS ON THE AGENDA (MAXIMUM OF

A member of the public made the following comments:

- They gave full credit to the Illogan Parish Neighbourhood Development Plan Steering Group for all their hard work producing the draft plan.
- They had looked at the draft plan and felt that it was a golden opportunity to lay down the way we wanted to go forward.
- They believed that this Council was well ahead of most other Parish Council's in the area and that the plan produced could become a template for other areas in Cornwall.
- They would like to see a table of the polices included in the plan in one easy to find place so that people did not need to go through the whole document to locate them.
- They also felt that it would be helpful to compile a list of all the social housing in the Parish.

FC18/01/29 TO RECEIVE THE DRAFT ILLOGAN PARISH NEIGHBOURHOOD DEVELOPMENT PLAN, NOTE ANY COMMENTS AND APPROVE THE DOCUMENT FOR PRE-SUBMISSION CONSULTATION

Cllr Ford queried whether there should be anything included in the plan on the management of surface water drainage. The Steering Group members confirmed that drainage was covered in the draft Plan on page 31 and by policy 26 of the Cornwall Local Plan.

In response to a question the Steering Group confirmed that once the presubmission consultation had been completed and submitted to Cornwall Council that Cornwall Council would then complete the sustainability appraisal.

It was noted that the definition of affordable housing is included in the document. It was also noted that affordable housing was referred to in two places on page 16 item 5.12 and page 17 item 5.17. It was queried whether all the points regarding affordable housing could be cross referenced, perhaps in a footnote.

Page 8 - item 3.7 - it was noted that the last sentence was incorrect and the Lady Bassett bequeathed the land to Revd Treweeke and not the people of the Parish. The Steering Group members were aware that the sentence was not accurate and that they had been looking into the matter at the Cornwall Records Office; they agreed to remove the last sentence and to include the correct information.

Page 25 – item 5.35 – the last sentence read as if there were buses that ran to Treliske every half an hour whereas they only ran once an hour in that direction. The Steering Group agreed to reword the sentence.

Page 6 – The Preparation Process – it was noted that the stalls at Illogan Parish Fair had not been included in the list; the Steering Group agreed to add the stall at Illogan Parish Fair to the list of consultations that had taken place.

Page 18 – figure 5 – in response to a question the Steering Group explained that there had never been any officially adopted settlement boundaries for the area. The settlement boundaries included in the plan were the same as the boundaries included in draft plans created by the former Kerrier District Council.

Parking Spaces – it was believed that during the Extra Ordinary Planning meeting which had previously been held to discuss the Neighbourhood Development Plan, there was a section that stated that there had to be 2 parking spaces per new dwelling. It was noted that the Council had not seen anything worded as strongly and that they would like it included in the plan. A Councillor wondered how the provision of 2 parking spaces would fit in with the National Planning Policy Framework and whether it would be able to be included in the Plan. The Steering Group thought that parking spaces was covered in the Cornwall Local Plan, they agreed to look into parking space provision and include it in the Plan.

Page 28 – Objective: to protect and enhance green corridors; between the Parish's individual settlements and between the Parish, Camborne, Pool and Redruth – the Council requested that Portreath was included. The Steering Group stated that there was some overlap with protect gaps in figure 6, the Group agreed to include Portreath.

A letter had been received from the Tehidy Residents Association. A member asked whether the Steering Group had taken the comments on board and if so how. The Steering Group said that they had sought advice from the Cornwall Council Neighbourhood Development Team. The policy on development in gardens had been included in response to the comments from the Tehidy Resident Association and the advice received from the Cornwall Council Neighbourhood Development Team. On page 21, the narrative had been provided by the Tehidy Residents Association. The Group felt that it was unfair to include policies for no development for one specific area as it would then increase the burden for development on other areas of the Parish. They felt that the policy was self-regulating, as if residents did not put their gardens forward for development then they would not be built on. Cllr Mrs Roberts asked the Steering Group to consider the letter from the Tehidy Residents Association as part of the pre-submission consultation.

The Steering Group were congratulated on their hard work, the generic policies that they had produced and the way they had dealt with pressure groups.

Members asked the Steering Group members to comment on the email sent by Cllr Szoka regarding anthrax. The Steering Group had sought advice from Cornwall Council and had received the following response which had been forwarded to the Clerk; the Clerk reported that the email would be circulated for the February Full Council meeting where members would be able to agree any future actions etc.:

'Anthrax is a pathogen not a substance and therefore does not come under the contaminated land legislation.

However, the senior Environmental Health Officer has been working with colleagues in animal health to investigate reports of potential anthrax contamination in Illogan parish. Animal health have written reports for cases since the 1950s, which includes details of their disposal – but you report that this case is earlier than that and there is no written record of it.

If there is suspicion of anthrax, environmental health would take a precautionary approach. In this case there was a full investigation, involving Public Health England and a geophysics survey was carried out which revealed no evidence of buried carcasses. The evidence from those reporting the incident was also conflicting –with some reporting that the carcasses were burnt and others that they were buried. In any case, the geophysics search was carried out and no burial pit found.

I don't think there is evidence to reasonably justify a policy in the plan requiring an investigation into all sites. If the parish council require

more reassurance I'd suggest contacting the senior Environmental Health Officer for procedural issues –although he is in contaminated land rather than animal health, it is a public protection issue and he clearly had had dealings with this specific concern.'

Cllr Mrs Roberts reported she had had met with the MP George Eustice and had asked him to get all the information that he could on the Glebe Field.

Page 11 - item 4.2 - it should read 'Clifton Road' and not 'Clinton Road'.

Page 21 - Policy PH4b - should read 'The site'

Cllr Ekinsmyth entered the meeting at this point at 7.31pm.

It was proposed by Cllr Ford, seconded by Cllr Mrs Thompson and

that the draft Illogan Parish Neighbourhood Development Plan is approved for presubmission consultation with the following amendments:

- Page 6 that the stall at Illogan Parish Fair would be added to the list of consultations that had taken place;
- Page 8 item 3.7 that the last sentence is removed and rewritten with the correct information about the bequeathing of The Glebe Field;
- Page 11 item 4.2 amend to read 'Clifton Road' and not 'Clinton Road';
- Page 21 Policy PH4b amend to read 'The site ...';
- Page 25 item 5.35 that the last sentence would be reworded to clearly explain the frequency of buses and where they go;
- Page 28 that the objective is amended to read 'To protect and enhance green corridors; between the Parish's individual settlements and between the Parish, Camborne, Pool, Portreath and Redruth; and
- that the Illogan Parish Neighbourhood Development Plan Steering Group would look into and include a policy that states that there must be the provision of 2 parking spaces for every new dwelling erected in the Parish.

On a vote being taken on the matter there were 7 votes FOR and 0 votes AGAINST.
