The vegetation is growing over the tarmac preventing users from utilising the full width of the path as it is causing the surface to be uneven. A local

resident fell last year and broke their wrist due to the unevenness of the path. Illogan Parish Council requests that the vegetation is removed to reinstate the full width of the path, that the collapsed fence is replaced and that the "No motor cycles" sign is put back up. Members would like to thank Cornwall Council for removing the barbed wire and arranging for surface repairs to be completed.
