Planning Applications

From May 2019 to May 2020 Cllr Mrs Jill Ferrett was the Chairman of Planning & Environmental Services Committee and Cllr Mrs Maggie Thompson was the Vice Chairman.

In 2019 the Council was consulted on 68 planning applications within the Parish. The Council has taken its responsibilities seriously and each application has been considered on its own merits and in the wider context of the area in which it is situated.

The Council agreed with Cornwall Council's decisions on 60 planning applications; disagreed with Cornwall Council's decision on 5 applications; 2 applications were withdrawn and not taken any further; and 1 application is yet to be decided by Cornwall Council.

Grants

The Council is committed to supporting and helping local community groups improve the quality of life for residents of the Parish. One way it does this is by providing grants. The Council's Grant Award Policy aims to ensure that all grant applications are treated equally and fairly and that grants awarded provide value for money; that all awards are within the legal powers of the Council; and that the grant process is open and transparent.

In 2019/2020 the Council provided grant funding to:

Park Bottom Institute - £260 towards replacing the fascia boards and new tablecloth and cushions.

Cornwall Air Ambulance - £300 towards the New Heli Appeal.

Ray Uren Award

Ray Uren was born in Illogan and was a Burma campaign veteran. He took a close interest in the life and affairs of Illogan and was a very regular attendee at the meetings of the Parish Council; he became a local Councillor after a by-election, for the last 3 years of his long life. The Award was instituted in his memory and is made on nomination from the public at large to mark outstanding contributions to the community in any field by any individual outside paid professional duty. Serving Councillors cannot be nominated for the Ray Uren Award.

The Ray Uren Award was awarded to Mr Andrew Tompsett. Andrew has been a consistent servant of Parish matters for many years. He was a friend of Manningham Wood, providing advice and arranging for the placing of bird nesting boxes. He was instrumental in obtaining and placing the nature signs.

He has contributed to St. Illogan Churchyard as a Living Churchyard and advised on conservation issues surrounding that scheme.

He has advised on and enabled the planting of apple trees in several locations around the Parish including Illogan School, where he arranged for pupils to help to plant trees.

He has enabled the saving and renewal of the ancient apple orchard in Tehidy Country Park thus developing a community orchard, at the same time involving local volunteers of all ages to help. He has also provided training opportunities for those interested in the selection, planting, pruning and grafting of apple trees.

He has judged horticultural produce competitions at local events and annually ensures that the interior of St Illogan Church is a blaze of floral colour at Easter.

He led the team of Illogan School pupils and other volunteers in the Well Dressing at Marys Well in the Olympics year 2012.

He provided at the request of the Parish Council 11 years ago, an illustrated report on the Parsonage Well area, with advisory comments.
