Residents of The Meadow, Illogan gave their reasons for objecting to the planning application PA21/07502 Land South West of 4 The Meadow, Illogan

 Loss of public open space and wildlife habitat. The applicant has previously felled trees. The planning application to erect a dwelling was submitted within 48 hours of the Certificate of Lawfulness being issued.

- The proposed development will destroy the open plan nature of The Meadow.
- The land was designated as an open space where children could play. This has now been lost.
- The loss of existing views from their properties.
- 1.8 meter high fence not in keeping with the open nature of The Meadow Estate.
- There are already parking problems which exist in The Meadow. The turning circle, which the applicant proposes to use as access to his bungalow, is already subject to congestion, as it is already used as a parking area.
- Properties in The Meadow are set back from the road. This proposed bungalow is located in a position close to the access road.
- Previous appeal rulings stated that the land must remain as a garden and permitted development rights were removed.
