A member of the public reported that they had lived in the village all of their life. They had recently walked around the area and were disappointed with

the state the village was in. The footpath in Manningham Wood was full of leaves which hadn't been cleared and there was dog waste which hadn't been picked up. The fence alongside the churchyard has been pushed over and was decaying in the vegetation. Young trees in the woods were being stifled by the undergrowth. The signage needed to be cleaned. During their walk around the village they had not seen any litter bins. The verges in Coronation Road, Oxland Road and Churchtown Road were a disgrace, cars were parking on them and they had been reduced to mud. They suggested removing the verges and installing parking bays instead. They felt that the Parish Council should deal with the state of the area.

Cllrs responded that the Parish Council did not have infinite resources to rectify all of the issues in the area some of which were being created by some residents. The Council and Cornwall Councillors for the area had been trying to resolve issues with the verges in Coronation Road, Oxland Road and Churchtown Road for a number of years. The situation was complicated due to joint ownerships and the policies of other organisations. The issues were on a list to be actioned by the Chief Executive of Cornwall Council. It was agreed that the issues raised would be further considered as an agenda item at the next meeting.

The applicant for the planning application for Druids Leap offered to answer any questions from members about the application.
