TO CONSIDER HOW TO MAKE THE NOTICEBOARDS STAND OUT FOR CL22/03/9 THE QUEEN'S PLATINUM JUBILEE

It was noted that positive comments had been received about the noticeboard on The Platt being painted green.

Members were concerned that if bunting was put around the noticeboards that it would attract vandalism. Therefore, it was agreed that the noticeboards would not be made to stand out for the Queen's Platinum Jubilee.

It was noted that legislation prohibited the Council from hosting an event that restricted participation to the elderly. It was therefore agreed not to progress with this item.

Members noted that Feast Days were religious events hosted by the local church. It was agreed to ask the rector of St Illogan Parish Church whether they had any plans to bring back Illogan Feast and if so, to offer the Councils hep.

Members discussed events being held by other organisations for the Oueen's Platinum Jubilee:

St Illogan Parish church was considering inviting parishioners to come and celebrate the jubilee by bringing and sharing a picnic in the grounds of the church, either the Saturday or the Sunday of the jubilee weekend, depending on which day looked warmest and driest nearer the time.

Illogan Royal British Legion were considering hosting a Party in Oxland Park for members and their children. As they were a registered club there were conditions imposed on them and they were therefore looking into whether they could open the event to the general public.

Members were aware of events being organised by Gwel an Mor and Heartlands.

Portreath Parish Council were lighting a beacon.

That an article would be placed in the Illogan Review advertising that a commemorative bench is being purchased and asking the public for their suggestions on where on The Platt the bench should be placed.
