Cllr Crabtree reported that as a Cornwall Councillor he would be responding to the appeal. His response was a work in progress and so far, included that he agreed with all representations that had been submitted by all parties. The previous layout had been accepted. The Planning Inspector that approved the outline permission wrongly stated that the Illogan Parish Neighbourhood Development Plan was in its early stages when it was actually 1 week away from going to referendum. The proposals are out of character, there are no other tandem developments in the area. All of the properties proposed are of a very similar designs, the 3-bedroom properties include a study whereas the 4-bedroom dwellings are all bedrooms. The parking provision is not in line with Policy TT2 of the Illogan Parish Neighbourhood Development Plan. He would also mention the historical significance of the area.

It was proposed by Cllr Ford, seconded by Cllr Pavey and

that Illogan Parish Council responds to the planning appeal for Land Adjacent to Fair View, Bassett Road by reiterating its previous objections to the Reserved Matters application. As a Planning Inspector has already decided on a layout for the site when approving the outline application, which has changed at the reserved matters stage, the Council do not expect another Inspector to go against this decision as it would make a mockery of the system. The proposals do not comply with Policy TT2 of the Illogan Parish Neighbourhood Development Plan:

"Policy TT2 Residential Parking - Proposals for all new homes should provide for one off road parking space for each bedroom, unless otherwise justified having regard to site specific circumstances and Cornwall Council parking standards.

Any garage facility provided as integral to or part of any single home or development should be of a size commensurate with use by an average sized motor vehicle."
