## TO RECEIVE THE CORMAC SOLUTIONS TRAFFIC REGULATION ORDER (TRO) FOR CORONATION ROAD, AGREE A RESPONSE AND ANY FUTURE ACTIONS

There had been issues with parking and the condition of the verges in Coronation Road for several years. There had been many discussions between Coastline and Cornwall Council. A survey had been circulated in the Illogan Review to obtain local views on the options; there was no clear majority. There would be a high cost to change front gardens into driveways and this would also not be very environmentally friendly. There were concerns regarding the accessibility in the area for a fire engine if one was required. It was noted that the garages in the area were not large enough for modern cars. Blue badge holders would get dsisabled parking bays.

The proposal was for a mixture of parking bays and yellow lines.

Coastline had received 3 objections to the proposals.

#### Members discussed:

- How many spaces currently used to park cars would be lost
- That there were more parking space being removed than created
- That people were only parking on the verges at there was nowhere else to park

- That residents did not have any rights to park outside their own property
- There should be space for all residents to park close to their homes by including parking in Church Road
- Charging electric vehicles. It was noted that there were no plans for cars to be charged at residences; there would be communal charging points
- Where vans would park. It was believed that there were no vans currently parked overnight in the area
- The design of the scheme
- The use of grass blocks, to maintain the current level of parking spaces but maintain the aesthetic of the area. There was no funding for this until at least 2023
- Why the proposals were no waiting at anytime and not time restricted
- The history of parking, previous scheme designs and why nothingh has come to fruition to date
- Concerns about access for the emergency services auch as the ambulance and fire service, especially in the evenings

It was proposed by Cllr Ford, seconded by Cllr Cullimore and

that the following response is sent to the Cormac Solutions Traffic Regulation Order (TRO) for Coronation Road:

"Illogan Parish Council would like to make the following comments regarding the proposed scheme for Coronation Road:

The Council has severe reservations that the scheme does not allow for the charging of electric vehicles in the future.

There are severe doubts on the practicality and appropriateness of the use on no waiting at any time restrictions.

The Council is disappointed that the scheme is being controlled by financial matters and not reality. For example, it would seem that this plan revolves around budgetary constraints that a more suitable scheme may be able to be delivered if it waited for the next budget; it feels premature.

The installation of grass blocks would enable access for the current parking and allow for the area to remain maintained.

The plans do not indicate how many parking spaces would be lost."

On a vote being taken the matter was approved unanimously.

### PM22/12/12 TO CONSIDER HOW TO PROGRESS THE SUGGESTIONS ON THE GREEN SPACES REPORT, AGREE ANY FUTURE ACTIONS AND ANY ASSOCIATED EXPENDITURE

Members felt that the Council should be careful not to complete maintenance on privately owned land.

A member of the public felt that some elements of the report could be completed by volunteers with the assistance of Illogan Parish Council. Illogan Park had been vastlty improved and they felt that other areas in the Parish also needed attention and improvement. They felt that not everyone visited Illogan Park to had a use for it and that the Council had focused on the park and neglected other areas. The Council should involve the community. The regeneration of The Platt had not yet been completed, this must not be forgotten or left to deteriorate further.

Members felt that there was an opportunity to do something on carefully selected areas. The Council would need to make sure that all necessary health and safety, training and insurance requirements were met.

It was noted that the parish covered a rural area and too much tidying could make it look too clinical and the character of the area could be lost. Overgrown areas attracted wildlife, if areas are too maintained it could be devastating to local wildlife.

It was proposed by Cllr Williams, seconded by Cllr Cullimore and
