It was noted in 2020, the Council had declared a climate emergency and had resolved to set up a committee to consider climates issues and that unfortunately due to the Covid-19 pandemic this had not been progressed.

It was felt that the role of councils was to make the life experience who live in the area more delightful by having green spaces and a choice of things to do. Illogan Parish Council needed to look at what could plausibly be addressed and that would need strong support from Full Council.

Green spaces were important and could offer so much to the community. It was important to find out what was available and to have a plan. Community gardening encompassed so much, gardening for wildlife was important and allotments were always in demand. It doesn't take much to bring a community together.

Climate change and the cost of living had created high blood pressure and high heart rates. Planning had granted permission for lots of building on fields and the planning department was at fault for that. It was also noted that in some circumstances managing land could ruin wildlife habitats.

It was suggested separating planning from environmental issues. There were members of the public willing to volunteer who were very hands on but not meeting orientated.

A discussion should be had to find out what the public want. There was a suggestion to include an article and survey in the next Illogan Review or a consultation at the upcoming Fun Day. It was also mentioned that councillors should canvass residents close to the green spaces for their opinions.
