# PUBLIC PARTICIPATION ON ITEMS ON THE AGENDA (MAXIMUM OF 10 MINUTES – EVERY SPEAKER HAS A LIMIT OF 3 MINUTES UNDER THE COUNCIL'S STANDING ORDERS)

Cllr Ian Stewart from Portreath Parish Council advised that they had unanimously objected to the two Gwel An Mor planning applications. Whilst the Gwel An Mor estate had benefited the village, it was now felt it was in danger of swamping the village with its increase in size.

In the planning applications transport plan it was claimed there would be no material change in occupancy the change would result in occupancy going from a maximum of 20 people to 60 people. It was also full of errors and gave a misleading impression. It mentioned bus services that no longer served Portreath and cycle hire that that had been closed for 3 years.

The full occupancy of the two planning applications combined would be 106 people.

There was no reference to the Portreath Neighbourhood Development Plan and policies 1 and 3 which they would be in contravention of.

The infrastructures for water supply, surface runoff, sewage and electricity were not there now, and the capacity had not been proven to be available from the utility companies.

They believed Gwel An Mor was now as big as the village could withstand and asked that Illogan Parish Council also objected to those applications.

The General Manager from Gwel An Mor spoke to the company's care for sustainability and stewardship. She noted they had achieved a lot like going plastic free in the lodges and using a dissolvable product.

Concerns had been raised about the wildflower meadow no longer being there, but she advised that this was because they were now not in flower.

Gwel An Mor employed lots of people from the area and had contributed to the local economy.

She noted that a shuttle bus had been put on for occupants of Gwel An Mor between 10am and 5pm every day. This also offered transport to Truro, St Ives and the train station. This would continue and grow if needed.

She advised that although the occupancy amount would rise overall, the annual occupancy for the site was 65% which brought those numbers down and that the site had the best intentions.

The Council raised that the speed limit past Gwel An Mor was currently 60mph and that many years ago the site had agreed to help with costs to have this reduced. They asked the General Manager if she would still be open to this and she responded that they would be happy to consider it.

The mains sewage system would be overloaded. Badger setts can extend 50m underground, there needs to be an in-depth survey completed before any planning decisions are made.

Comments in favour of the proposal noted:

- Evidence where this had already been implemented it had increased road safety.
- Cyclists more likely to use Cornish roads if they were reduced to the 20mph speed limit.
- Would help issue with crossing roads in the parish.
- In the trial areas of Falmouth and Camelford 85% of road users stuck to the 20mph limit.

Comments opposed to the proposal noted:

- Reduced speed limit would increase pollution and cause annoyance to drivers.
- A blanket speed limit was not necessary and should just be in key areas like estates and by schools.
- It doesn't cover important areas such as 60mph stretches of road like Spar Lane and these areas could become more dangerous.
- Could cause nuisance to residents where the speed limit changes from national speed limit to 20mph due to gear and rev changes.
