Minutes of the Projects Committee held in Illogan Parish Council Community Office, Trevelyan Road, Illogan Thursday 20th April 2023.

PC23/04/1 TO RECEIVE APOLOGIES FOR ABSENCE

There were no apologies to receive.

It was noted that the Mobile Speed Activated Signs did not need to be sourced from Cormac but that Cornwall Council Highways regulations would still need to be followed.

It was suggested that any fountain would need to be near the office building for ease of getting a water supply.

Systems with a water release system should be considered carefully due to the risk of vandalism and the anti-social behaviour in the area.
