Cllrs Hodge and Wing offered to do the leaflet drop for the Illogan Christmas Light Event road closure.

The grotto at the Robartes Arms had steps to access it. Disabled children would be brought to the front of the queue. The Tolvaddon event would be advised as having disabled access.

Stewards at the Tolvaddon event would start just before 5.30pm and finish at approximately 6pm. They would be contacted by radio to confirm that they were no longer required.

The sleigh for the Illogan event was confirmed to be light-weight and would be pulled by physically capable volunteers. There would be extra people behind the sleigh between it and the parade in case of any issues. The Clerk would update the Risk Assessment to reflect the additional information.
