PM26/05/13 TO RECEIVE AN UPDATE ON THE REQUESTS MADE TO CORNWALL COUNCIL AND DEVON AND CORNWALL POLICE REGARDING A PUBLIC MEETING TO DISCUSS THE ISSUES AFFECTING BASSETT ROAD AND THE SURROUNDING AREAS AND AGREE ANY FUTURE ACTIONS.

The Clerk reported that, since the agenda pack had been circulated, she had received further correspondence from Devon and Cornwall Police. The Police had undertaken additional investigations into the incidents on Bassett Road and noted that they involved driver intoxication and a medical episode. Parking pressures on Bassett Road were also identified as a potential contributing factor, particularly due to vehicles parking to access the nearby shop and chemist. The introduction of double yellow lines was considered a possible option, although it was acknowledged that this could create further issues elsewhere. The Clerk advised that she had a meeting scheduled with the Police Inspector to discuss the matter and potential options, and that she would report back following the meeting.

Members discussed the following points:

- The administrative processes and legislative restrictions and burdens within Cornwall Council and Devon and Cornwall Police, and the impact these have on the actions that can be taken.
- The general reluctance and apathy among members of the public to report near misses, due to a perception that no action is taken in response. This creates difficulties as there is insufficient recorded evidence to support requests for measures to address the issues.
- The ongoing parking and traffic issues on Bassett Road, partly arising from insufficient off-road parking provision for the increasing number of vehicles per household. Members noted that roadside parking was increasing and traffic volumes were becoming heavier.
- The situation on Bassett Road being further exacerbated when deliveries were made to the shop, requiring delivery lorries to stop on the road.

- The view that parked vehicles can also serve as a form of traffic calming by reducing vehicle speeds.

It was agreed that Officers would contact Cornwall Council Highways to request a review of historic street imagery for Bassett Road to determine whether yellow lines had previously been in place. Members noted that reinstating former restrictions may be more straightforward than introducing new traffic regulation measures.

It was further agreed that an article would be drafted for the Illogan Review encouraging residents to report any near misses witnessed or experienced on Bassett Road to Devon and Cornwall Police, to build an evidence base to support future action. Members also suggested that Officers contact the resident who had recently approached the Council regarding the matter to ask whether they would be interested in contributing the article.

The Council notes with concern that, although approximately half of private sector organisations produce private risk assessments, these tend to place greater emphasis on carbon emissions than on climate adaptation.

The Council welcomes the proposed progression to Stage 5 and the widening of the scope of organisations expected to be involved in future adaptation and resilience planning.

The observations made by a number of local Members of Parliament during the Westminster Hall debate of 10 March have also been noted.

Illogan Parish Council supports the broad recognition of the challenges arising from extreme climate and weather events, together with the associated need for a more coordinated approach across government departments, consistent with the Declaration of a Climate Emergency."
