discussed the success of other plaques in the surrounding areas, with a discussion on the most suitable location including around the wooden planters, plastic benches and in garden spaces with the future potential to include in the new sensory garden. Members discussed the need for a policy to include standard sizing, and materials and applications.

PM26/03/14 TO RECEIVE CORRESPONDENCE REGARDING SUGGESTIONS TO SAFEGUARD VULNERABLE USERS OF ILLOGAN PARK, AGREE A RESPONSE AND ANY FUTURE ACTIONS.

Following an incident in Illogan Park, it had been suggested that the Council should consider creating designated safe walking areas, ideally divided by low fences (similar to around the car park) or hedges, where dogs are kept 'under strict control' at all times on a lead, helping to prevent vulnerable individuals from experiencing similar incidents or distress. While we recognise that the incident was distressing for the individual involved, and that a similar occurrence could be equally concerning for others, the proposed style of fencing would not provide a meaningful barrier between people and dogs as intended. In practice, dog walkers frequently allow their dogs off leads near the existing car park fencing, and the dogs are able to pass under or over it with ease.

Current accessibility guidance emphasises minimising barriers wherever possible. For example, the Ramblers Association is actively supporting initiatives to improve access by removing obstacles such as gates.
